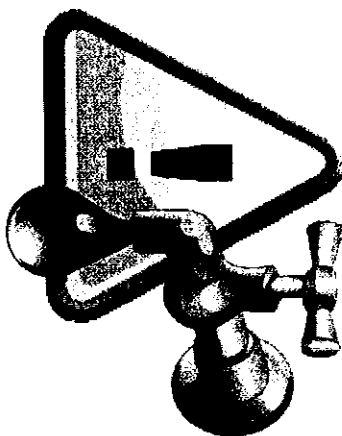

BACKGROUND

Public Notification (PN) helps to ensure that consumers will always know what to do if there is a problem with their drinking water. In May 2009, important revisions to the PN rule became effective that must be put in practice by community water systems. In addition, there are new PN direct delivery requirements that go into effect in May 2010 that systems should begin preparing for now.

WHAT YOU WILL LEARN

This course will teach you how to use the revised PN Handbook (provided) as a reference guide for all public notification requirements, including how to prepare for the new Tier 1 direct delivery requirements. Participants will also learn how to implement the DEP policies regarding water supply warnings and loss of positive water pressure situations. The course additionally reviews updates to the Operation & Maintenance Plan and Emergency Response Plan templates according to the new PN planning requirements.

WHO SHOULD ATTEND?

The course is designed for community drinking water systems, and is applicable to treatment plant and distribution system staff.

Due to class size, we ask that each system initially registers only two individuals. So, if possible, a system should send one treatment plant and one distribution system representative responsible for PN decision-making in each of these work areas.
