Dear Green Industry Professional:

Have your customers been requesting native plants in the work you do for them? Many savvy home gardeners are aware that native plants may be well adapted to the conditions in their landscape and are seeking them out.

If you'd like to tune up your knowledge of natives, this class may be just what you're looking for! This two-day class concentrates on trees, shrubs and herbaceous plants considered native to southeastern Pennsylvania, and will give practical information of how you can use these plants in the landscape.

- Emphasis will be on plants that are readily available in the nursery trade.
- Add some new plants to the palate you offer your customers.

Join us for two informative days which will combine classroom time and hands-on workshops. No prior study of native plants is required.

The instructor is Dr. David Sanford, Professor of Horticulture, Penn State University. The cost is \$70 which includes lunches and handouts. **Registration deadline is September 1, 2009.**

## **Directions:**

The Pool Wildlife Sanctuary is located in Emmaus, Pennsylvania, 4.2 miles from center-city Allentown and 2.5 miles from the Cedar Crest Boulevard exit from I-78.

From I-78: Exit at Cedar Crest Boulevard (Route 29), turn south (toward Emmaus) onto Cedar Crest Boulevard and follow directions from Allentown.

From Allentown: Follow Cedar Crest Boulevard (Route 29) south to the intersection of Riverbend Road, 1.3 miles from the I-78 exit. Turn left onto Riverbend Road. Take the first right turn onto Orchid Place and proceed down the hill. At the white bridge (on the right, about 0.3 miles), turn right and cross bridge into the Sanctuary.

From Bethlehem: Travel through Fountain Hill on Emmaus Avenue toward the Borough of Emmaus. One mile past I-78, turn right at the "Y" onto Harrison Street. Follow to Macungie Avenue (third stop sign); turn right; road turns into Orchid Place; at the bottom on the hill turn left and cross bridge into Sanctuary.

From Emmaus and south: Take Cedar Crest Boulevard (Route 29) north. Turn right on North Street, take first left onto Macungie Avenue (third stop sign); turn right; road turns into Orchid Place; at the bottom on the hill turn left and cross bridge into Sanctuary.
